<p><b>Course Description</b></p>	<p>This is a learning experience that will help the participant gain knowledge and build skills to track implementation of <b>Healthy People 2020</b>. Healthy People 2020 offers MAP-IT as a framework for implementation (<b>Mobilize, Assess, Plan, Implement, Track</b>). This course covers the <b>Track</b> section of that framework for Implementing Healthy People which draws upon free resources available from the <b>Community Tool Box</b>. The MAP-IT framework helps create a path to a healthy community and Nation. The course includes a test and evaluation to be submitted for credit.</p> 
<p><b>Course Goals and Objectives</b></p>	<p>The goal is to prepare health professionals and partners track partnerships and action to solve health problems. They will be able to find and keep partners engaged, facilitate community input, develop and present education and training, lead fundraising and policy initiatives and provide technical assistance in planning and evaluation.</p>

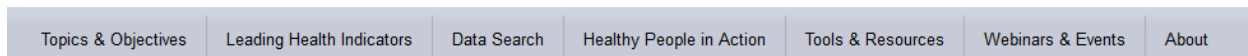


The course covers the **Track** section of **Implementing Healthy People**.

Throughout the “Study Guide” each study assignment can be opened from the electronic version / pdf file or from the Healthy People 2020 and the Community Toolbox web pages.

You will be asked to read each page and click on and read text from links on those pages. In all there are hundreds of pages of information, resources and tools beyond the original pages you will be asked to read and review.

The test has both multiple choice and short answer questions. Since there are more components to understanding how to mobilize than this nine hour course can cover you are not required to read every page. You will have the opportunity to select components you feel are most relevant to you. Be prepared to very briefly and concisely (≤50 words) describe the component you selected when you take the test.

Do this for two reasons: 1) for your records and 2) depending on your email program you may need to send the file as an attachment. If you use something like gmail, aol, yahoo not in conjunction with Microsoft Office Outlook you need need to save the file to attached. Using MS Outlook allows you to click on a submit button to send the answers. Either way is acceptable</p> <p>Be sure to use <b>Adobe Reader XI</b> which allows you to see your answers, see the calculated score on one of the last pages of the test, and go back and change answers.</p> <p>Get <b>Adobe Reader XI</b> for PCs and Macs at these links:  <a href="http://www.adobe.com/products/reader.html">http://www.adobe.com/products/reader.html</a>  The link should determine and indicate in text of the page which “system” you’re using after you click the “Download now” button.</p>
